1973: ELECTION OF OFFICERS:

Chairperson: It was proposed by J. Bowden that E Champion be elected as Chairperson for the forthcoming year. This was seconded by B. Woodward and was a unanimous decision by all Councillors present.

Finance Officer: It was proposed by A. Gilling that V. Clapp continue as Finance Officer. This was seconded by L Spokes and was a unanimous decision by all Councillors present.

Emergency Planning Officer: It was proposed by A. Gilling that Y Roscorla and G. Willoughby be elected as Emergency Planning Officers. This was seconded by J. Bowden and was a unanimous decision by all Councillors present.
